Rental terms Archery Tag set Wageningen Archery Club

Definitions

Lessor: Wageningen Archery Club (WAC in short)

Lessee: The person or organisation who rents the archery tag equipment from the lessor. The users: Everyone who uses the archery tag equipment during the rent.

The material: All equipment that is needed for archery tag, that the WAC provides to the lessee. The rented material: All equipment that the lessee has in loan including but not limited to bows, arrows, helmets, bunkers and stringers.

Rent and rental price

The lessee can rent the equipment in different amounts. Furthermore, has the option to let their archery tag event be guided by a WAC member. The following prices apply to the possible rental options:

24 bows and helmets, 48 arrow: €120 12 bows and helmets, 24 arrows: €80 8 bows and helmets, 16 arrows: €50

Guidance: €30 for 2 hours of guidance on top of the equipment rental price.

The lessee can rent 1 or 2 inflatable bunkers without any extra costs. The lessee gets 1 or 2 stringers in loan to string and unstring the bows in a safe way.

WAC members can rent the equipment with 25% off the total rental price. The WAC rents their equipment only in Wageningen and surrounding places.

The lessee is allowed to cancel the rent maximum 48 hours beforehand without any costs. The lessee is allowed to cancel the rent maximum 24 hours beforehand, for which 25% of the total rental price will be charged.

If the lessee cancels the rent within 24 hours beforehand, they are obliged to pay the full rental price. The WAC has the right to cancel the rent at any moment, because of bad weather conditions to protect the equipment. If the WAC decides to do so, the lessee can choose to reschedule the rent or get a refund on the fully paid price.

Loan and transport of the rented material

The rented equipment stays property of the WAC at any time. The lessee is responsible for finding a suitable location for archery tag.

Suitable locations include, but are not limited to:

- Private terrain
- Terrain of an archery association that allows the lessee to play archery tag on their terrain.
- Terrain of another organisation that allows the lessee to play archery tag on their terrain.
- Not suitable locations include:
- Public accessible terrain
- Locations with limited space

In addition, the location must be in Wageningen or surrounding places. The lessee is responsible for the transport to the location and back.

The lessee is obligated to hand in all rented equipment at the WAC in good condition before the end of the rental period.

Handling of the rented material

The lessee is responsible for the users and that they handle the equipment in a correct manner. That is:

- Only people of 12 years and older use the rented equipment.
- All bows are stringed and unstringed with the provided stringers. Stringing by feet is not allowed.
- Users do not throw helmets, bows or bunkers. This also means that a user calmly lays down the equipment and does not throw it to the side after or in between use.
- Helmets are not touched at the vision window.
- Users will not bend arrows and will not stab or beat others with it.
- Users will only draw a bow with a knocked arrow (dry firing is strictly prohibited)
- Bunkers are placed on suitable terrain which is free from sharp objects. The bunkers are placed in such a way that they will not fall over.

After the lessee used the equipment and handed it back to the lessor, the lessor will check the equipment and repair or replace equipment if needed. To keep the material clean and hygienic the lessor will disinfect all helmets.

Deposit

The lessee is obligated to pay a deposit of €200 with the payment of the rental price. If all rented equipment is handed back in good conditions and without damage or any missing parts, the deposit will be fully refunded.

For every damaged or missing element the following amounts are subtracted from the refunded deposit:

Helmet: €25 Bow: €50 Bunker: €80 Stringer: €10 Arrows: €5 per arrow, when two or more arrows are damaged or lost. All other equipment: in consultation with the lessor.

Safety

For the safety of all users the WAC strongly recommends to only play dodgeball variants with the rented material. Variants like capture the flag or free for all are strongly discouraged due to the speed of the arrows, the orientation and the distance of the user relative to their target, and the possible increased chance of injury. Specific game rules and field dimensions can be consulted with the lessor.

To guarantee the safety of the users the following safety measures apply then playing archery tag:

- Access to the playing field only while wearing a helmet.
- Do not aim at somebody's head on purpose.
- Never shoot at someone within 5 metres distance, or at someone who turned their back to you.
- Make it clear to every user that in case of emergency, they have to hold up their bow in the air. Upon this sign, the game is paused immediately.

Also with these safety measures a hit by an arrow can still hurt. Be aware of this.

Liability

The WAC is not liable for any form of damage or injury received while using the rented material. The WAC is not liable for any problems that occur due to the practice of archery tag on a not suitable location.
